The manner in which delinquent taxes on mobile homes are collected has been changed by the enactment of the Mobile Home Local Services Tax Enforcement Act. Failure to pay this tax can result in a penalty of \$25.00 per month.

The introduction of this law, in a worst case scenario, can result in loss of your mobile home for nonpayment of taxes, beginning in collection year 2003. Please read the back of this bill for further information.

IF TAXES ARE NOT PAID:

By September 19, 2025 you will be sent certified mail alerting you of your lack of payment, and notice will be listed in publication of a local newspaper. The law requires us to do this to be sure we give you every opportunity to be aware of your tax situation.

By October 27, 2025 judgment will be filed against the mobile home owner, and mobile home taxes will be sold to a tax buyer at the St. Clair County Tax Sale on November 07, 2022. Be aware that additional costs and fees will be incurred with the sale of your tax at this sale.

The purchase of your taxes at a tax sale is not the purchase of your property, only the taxes. The purchase will consist of the total mobile home tax due plus interest, cost and fees with bidding starting at 18 percent and decreasing.

- If you own the mobile home and it is abandoned, you have one year from the sale date to redeem the taxes or the tax buyer may file for title certification from the State of Illinois.
- If the mobile home is occupied, you have two and one-half years from the sale date to redeem the taxes before the tax buyer may file for title certification from the State of Illinois.
